

PRIVACY POLICY

Turn 1 Insurance Brokers (Pty) Ltd values the importance of protecting your personal information and we subscribe to the principles as outlined in Section 51 of the Electronic Communications and Transactions Act 2002.

1. PERSONAL INFORMATION

Personal information, for the purpose of this document, means all information specific to you, which is provided to Turn 1 Insurance Brokers (Pty) Ltd online – in other words, information that identifies you. This includes for, example, the following personal information that you may provide to Turn 1 Insurance Brokers (Pty) Ltd

Whenever you use this website, complete a quotation or application form or contact us electronically, we will process and collect your personal information.

Turn 1 Insurance Brokers (Pty) Ltd will use your personal information only as appropriate in the normal course of business. The following are reasons why we would collect your personal information:

- 1.1 to identify you;
- 1.2 to process your instructions to us;
- 1.3 to manage your policy/ies;
- 1.4 compliance with the laws of the Republic of South Africa;
- 1.5 detecting fraud; and/or
- 1.6 direct marketing to you via email or telephone.

Turn 1 Insurance Brokers (Pty) Ltd does not permit the selling or providing of personal information to third parties for independent use. At Turn 1 Insurance Brokers (Pty) Ltd we may, however, share your personal information with our partners if that information is required to provide you with the product or services requested by you. We will disclose your personal information when required to do so:

- 1.4 when you have expressly authorised Turn 1 Insurance Brokers (Pty) Ltd to do so.

We may also contact you about our products which we believe may be of interest to you. If at any stage after you have given us your consent, you change your mind and no longer wish us to contact you about our products, we will respect your decision. You will always be given the opportunity to instruct us to remove your contact details from our mailing list.

You have the right to access your own personal information that Turn 1 Insurance Brokers (Pty) Ltd keeps about you by following the procedures available under Turn 1 Insurance Brokers (Pty) Ltd Promotion of Access to Information Act manual available from Turn 1 Insurance Brokers (Pty) Ltd website.
